PRIVACY POLICY

The Privacy Policy contains information on how we collect, use and protect personal data of Users visiting the Website and contacting the Controller. If you do not agree with the provisions of this Privacy Policy, please leave the Website immediately.

This Privacy Policy is effective from 1 January 2021.

Article 1. Data Controller

The Controller of personal data collected through the Website is Eugenius.

Article 2. Definitions

Below we present definitions of the most important expressions used in this Privacy Policy:

- "Eugenius" or "Controller" Eugenius spółka z ograniczoną odpowiedzialnością (limited liability company) with its registered office in Poznań (61-324) at ul. Sanocka 3, entered into the Register of Entrepreneurs of the National Court Register kept by the District Court Poznań Nowe Miasto i Wilda in Poznań, 8th Economic Division of the National Court Register, under KRS number 0000468215;
- "Website" the website available at https://eugenius.eu/;
- "Personal Data" information about an identified or identifiable natural person ("Data Subject"); an identifiable natural person is one who can be identified, directly or indirectly, in particular by reference to an identifier such as name, identification number, location data, online identifier or one or more factors specific to the physical, physiological, genetic, mental, economic, cultural or social identity of the natural person;
- "GDPR" Regulation (EU) 2016/679 of the European Parliament and of the Council of 27
 April 2016 on the protection of natural persons with regard to the processing of personal data
 and on the free movement of such data and repealing Directive 95/46/EC;
- "User" or "Customer" any natural person visiting the Website;
- "Privacy Policy" this document.

Article 3. Scope of the data collected

We collect Personal Data that the User provides in the course of enquiring about products.
 Providing Personal Data is voluntary yet necessary for the registration of the User's enquiry
 and for establishing further contact with the User.

- 2. Personal Data collected by Eugenius include:
 - a. first and last name:
 - b. e-mail address;
 - c. any other data that the User chooses to voluntarily indicate.

in particular:

- d. residential or business address for the purpose of shipping the ordered goods;
- e. tax identification number (in the case of entrepreneurs);
- f. telephone number for the purpose of contact in the performance of the contract;
- 3. In addition to the Personal Data specified above, we also collect system data contained in system logs and information through cookies, which are collected automatically during the User's visit to the Website. (**Article 7**).

Article 5 Time of Personal Data processing

Users' Personal Data shall be processed by Eugenius for the time necessary to achieve the objectives for which it was collected, or longer if it is determined by the law.

Article 6. Rights of the User

In accordance with the provisions of the GDPR, every person whose Personal Data we process as a Personal Data Controller has the right to:

- access his/her Personal Data (Article 15 of the GDPR) The User has the right to obtain confirmation that his/her Personal Data is being processed, as well as access it and other information referred to in Article 15.1 of the GDPR;
- 2. withdraw consent to the processing of Personal Data at any time (Article 13.2(c) of the GDPR), where processing is based on the consent provided.
- 3. correct, amend, update, rectify Personal Data (Article 16 of the GDPR)
- 4. delete Personal Data "the right to be forgotten" (Article 17 of the GDPR) the User has the right to request the immediate deletion of his/her Personal Data.
- 5. request restricting of processing (Article 18 of the GDPR) The User has the right to request that Eugenius restricts the processing of his/her Personal Data.
- **6.** object at any time to the processing of Personal Data (Article 21 of the GDPR); lodge a complaint to the supervisory authority (Article 13.2(d) of the GDPR)

Article 7. Cookies and system data
